*In addition, depending on the County, some proceedings like custody and other conferences are being held via telephone. We will update each client with specifics about any changes to their cases/court proceedings as we receive the information, for the duration of this judicial emergency.*

**Per the March 19, 2020 Order of Governor Tom Wolf, until April 30, 2020, Sweeney Law Office, LLC will remain open remotely, we will be available to communicate with clients via telephone and, if necessary, video calls. We will have regular access to email, fax and U.S. Mail. Furthermore, some other firms are continuing to work remotely which will allow us to communicate with opposing counsel as well.
